### **7. ONTARIO SAILING - PRIVACY POLICY**

#### **DRAFT 06.11.06**

At Ontario Sailing we respect the privacy needs of our valued customers, members and partners. The following Privacy Policy outlines what specific information is collected by Ontario Sailing, in what manner, and how it is used, in compliance with the recent implementation of the Personal Information Collection and Electronic Documents Act. When personal information is supplied to Ontario Sailing it is used for the purpose for which it was collected (e.g. replying to you regarding a question you asked, registering for a program or course, etc.).

#### **Information Collection: Use and Disclosure**

*Ontario Sailing's purposes for collecting personal information are:*

- a. To establish and maintain responsible communication with our members, program participants, parents, donors, corporate partners, staff and volunteers;
- b. To manage, develop and enhance the programs and services of Ontario Sailing;
- c. To acknowledge gifts, issue tax receipts, and other administrative requirements including information requests;
- d. To process and collect fees for services and merchandise;
- e. To collect data for statistical purposes and to report consolidated data to our funding organizations as requested, specifically and primarily the Ministry of Health Promotions of the Province of Ontario.
- f. To communicate a range of programs, services, and philanthropic opportunities;
- g. To meet legal, regulatory and contractual requirements.

The Personal Information collected by Ontario Sailing includes:

- Your first and last name
- Your home and/or work mailing address
- Your home and/or work phone number
- Your fax number
- Your email
- Other information relevant to the specific event/program that this information is being collected for (ie: your boat name)

In some cases, this information is **shared** with partner organizations as follows:

- a) Sharing With Host Organizations: In any of our programs operated with a host organization, information required by them to run the event will be shared with them including such programs as Mobile Sailing Programs, Regattas, Learn-To-Cruise Instructor Clinics, and Ontario Sailing Association Regional Coaching (OSARC).
- b) Sharing With Canadian Yachting Association (CYA): In order to maintain a common information database and reporting system with CYA, personal information is shared with CYA including such programs as: Instructor Development Programs (Learn to Sail, Learn to Cruise, Learn to Power and Spark Start). This information is also shared with the course conductors. In the case of Learn to Cruise registrant's information collected is forwarded to the clinic host

- club/school/organization, and the course conductor(s), and successful candidate information to CYA.
- c) Donors: Information collected from individuals making a donation to Ontario Sailing will be shared with the Sport Alliance of Ontario, or the Canadian Yachting Association solely for the purpose of issuing a tax receipt and reporting subsequently to Revenue Canada.
  - d) Directors: Contact information of members of the Ontario Sailing Board of Directors is shared with the Ministry of Consumer and Business Services and matters related to the Corporations Information Act.

Ontario Sailing is not responsible for the security of the information provided to partner organizations for the purpose of maintaining registry database of participants, when the information is in the hands of those organizations. Please refer to the privacy policies of those respective organizations.

- Ontario Sailing presently maintains a listing of Instructors names and email addresses on our website ([www.ontariosailing.ca](http://www.ontariosailing.ca)). Instructors will be given an opportunity annually to choose to have the information posted or not. At any time an instructor may request to have this information removed from our website simply by contacting Ontario Sailing and making that request.

- Ontario Sailing will release your Personal Information if required to do so by law, or by search warrant, subpoena or court order.

- Unless otherwise disclosed during collection or in this Privacy Policy, Ontario Sailing does not provide any Personal Information to any third party for any purpose whatsoever.
